LOCALIZED HEALTH IMPACTS REPORT

Publication CEC-600-2010-009-AD**

The *Localized Health Impacts Report for Selected Biofuel Production Plants Awarded Funding Through the Alternative and Renewable Fuel and Vehicle Technology Program under Solicitation PON-09-604* was posted December 24, 2010, and the 30-day public comment period ended January 24, 2011.

On February 4, 2011, the California Energy Commission posted a Revised Notice of Proposed Awards resulting in an additional project proposed for funding under the Biofuel Production Plants grant solicitation PON-09-604 for fiscal year 2010/2011. The Energy Commission is required under California Code of Regulations, Title 13, Chapter 8.1, Section 2343(c)(6), to consider the localized health impacts and environmental justice when approving projects for funding.

The Energy Commission has published an addendum to the original Localized Health Impacts Report that analyzes the additional project proposed for funding under the Program. The addendum was publicly available on March 25, 2011.

The specific project analyzed in this report is:

- Solazyme, Inc.'s, "Development of Pilot Production Plants for Soladiesel RD™ Utilizing California Feedstocks"

The addendum to the report includes a description of the project, criteria emissions data for the fuels associated with the project, demographic data for the area where the project will be located, and an analysis of the impacts of this project in communities with the most significant exposure to air contaminants or localized air contaminants.
