DUTIES/RESPONSIBILITIES:

- Conduct the most complex research and analysis, and provide technical leadership, direction, and coordination in complex technical and analytical work supporting the Existing Buildings Program. Conduct research and analysis, provide technical assistance, and coordinate efforts to review, approve, and provide continued oversight of the Existing Buildings Program to increase energy efficiency of the existing building stock. Assignments may include, but are not limited to: (a) analyze, facilitate, implement, and/or strive to improve residential energy efficiency measurement programs, including asset ratings (e.g., Home Energy Rating System) and energy assessments; and (b) lead and perform technical, policy, and/or economic analysis regarding programs managed or overseen by the California Public Utilities Commission (CPUC), Investor-Owned Utilities (IOUs), Publicly-Owned Utilities (POUs), program implementers, and/or Local Governments (LGs) to enhance development and implementation of energy efficiency (EE) program portfolios. As a subject matter expert, provide guidance to project managers, who are implementing projects and programs. As a project manager, implement projects and programs.
- Serve as the State's subject matter expert on residential energy efficiency measurement programs and programs managed or overseen by the Publicly-Owned Utilities (POUs), program administrators, program implementers, and/or Local Governments (LGs). Provide technical and policy analyses associated with the Action Plan and residential energy efficiency programs. Support the development of energy efficiency targets consistent with the Action Plan, and develop recommendations for the Integrated Energy Policy Report towards achieving Senate Bill 350's doubling of end use energy efficiency goal. Coordinate analyses and recommendations with staff in other offices of the Efficiency Division, other Divisions within the Energy Commission, other agencies, utilities, non-governmental organizations, and the public.
- Manage contracts (including work authorizations) and grants related to the Existing Buildings Program, Barriers Study, and/or Local Government Challenge. Perform the duties of a contract manager, or assist the contract manager or project manager. Responsibilities will include

assisting in the preparation of business requirements for technical work, solicitation documents, work authorizations, or grant opportunity documents; conducting bidders' conferences; proposal evaluation and selection; negotiation of scopes of work, work authorizations, deliverables, and costs (labor fees and direct expenses); preparing contracts, grants, and request memoranda; assigning work; monitoring work progress; processing invoices; tracking expenditures; and preparing related, necessary paperwork.

- Present conclusions, recommendations and advise the Commission, other governmental agencies, and others on subject matter issues discussed above. As the State's subject matter expert and technical lead, attend workshops, hearings, and conferences on issues associated with the subject matter described above. Performing this duty may require travel.
- Perform other duties as required consistent with the specifications of this classification.

DESIRABLE EXPERIENCE/QUALIFICATIONS: The successful applicant should have:

- Knowledge of the Building Energy Efficiency Standards for Residential and Nonresidential Buildings;
- Demonstrated ability to use a variety of analytical and research techniques to assist in evaluating and quantifying the effect of building energy efficiency measures, assist in resolving energy efficiency problems, and develop and evaluate alternatives;
- Demonstrated ability of completed staff work;
- Knowledge of project management;
- Ability to communicate ideas effectively; and
- Strong written and verbal communication skills.

WHO MAY APPLY: Eligible candidates who are current state employees with status in the above classification or lateral transfers from an equivalent class, former state employees who can reinstate in this classification or persons who are reachable on a current employment list for this classification. Appointment is subject to the provisions of the SROA process: SROA / SURPLUS / REEMPLOYMENT candidates are encouraged to apply and must attach a copy of their status letter.

Interested applicants must submit a completed Standard State Application (Form STD. 678) with an original signature, to the contact/address listed below. Electronic applications will be accepted.

You must clearly indicate the basis of your eligibility (i.e., list, transfer, SROA/Surplus, reinstatement, etc.), RPA #420-346 and Position #535-420-4185-001 in the "Explanation Section" of the STD 678. A separate application is required for each position. Resumes are welcomed but do not take the place of the completed State Application STD 678. Will consider a Training and Development (T&D) Assignment. Applications will be screened for experience and only the most qualified will be contacted for an interview. **NOTE: Failure to comply with the filing instructions and incomplete applications received will not be considered.**

Please Note: Possession of the minimum qualifications will be verified prior to the interview and/or appointment. If it is determined an applicant does not meet the minimum qualifications, the application may be forwarded to the State Personnel Board for review and the applicant's name may be removed from the eligibility list.
