### **Background**

This all day workshop will present the research results, findings, conclusions, and recommendations of the California Renewable Energy Center under a recent Energy Commission-funded research contract, *Renewable Energy Resource, Economic, and Technical Assessments (500-11-020)*. The project addressed research and development needs for numerous renewable energy resources, including bioenergy, geothermal, solar, wind and small hydro, with a focus on technology and resource assessments for California.

Presentation topics will include integrated assessments of renewable energy technology options, with particular focus on the LA Basin as a case study; assessment of the potential for co-located renewable energy projects, including with existing oil and gas fields; opportunities for developing geothermal resources in under-served regions; and technical assessments of renewable energy technologies for solar heating and cooling, small hydropower, offshore wind, and numerous biomass conversion pathways.
